Location and history

- 3 periods
 - Fishing port
 - Maritime and Industrial
 - International tourism







- Fishing port
 - For locals and regional needs and market
- Maritime and Industrial
 - started from 1900s
 - major ports includes the rocks and Darling Harbour

• The rocks

- Walsh Bay & MillersPoint
- Wool industry originates around 1830s
- Warehouse and wharfs existed
- Plague → act of parliament:
 The rocks being a major wool export port
- Rebuilt of wharfs and warehouse
- Sales to Japan and China



Darling Harbour

- Plague → act of parliament:
 DH being a wheat export industry place (because wheat export also exist before)
- Till 1920s when production site transferred to Glebe island Gradually decline in wheat export
- Also decline of industrial industry in Sydney Harbour (water quality problems)
- WWII → soldiers and troops arrivals, departure and military




International tourism / other uses (1970s onwards)

- Commercial / residential / recreational
 - Darling Harbour (residential)
 - The rocks (mixture of recreational / tourism and residential)

Town Place

- City centre (wharfs, maritime service board)
 - → self-sufficient community
- Reasons:
 - Walsh Bay declined in use from 1970s
 - Facilities on island side became redundant


 Current uses: Shops, galleries, theatre, restaurant, apartments, offices



The Rocks

- Wool industries
 - → Appearance is kept but with new functions
 - → Colonial history and colour can be traced
- Reasons:
 - 1920s: Construction of Sydney Harbour Bridge
 - 1970s: Revitalization

Different Functions in The Rocks




- Bars, Restaurants, and cafes

Darling Habour

- Old industrial area (warehouse)
 - → Multi-Functional centre
- Reasons:
 - Decline of wool industries
 - make this prime city site -> a focal point







