The Zhujiang Delta region is the natural hinterland of Hong Kong. It has experienced astonishing growth since 1978 after the introduction of economic reforms and open policy in China. Its subsequent development is, in many ways, closely related with that of Hong Kong. In fact, far-reaching economic integration has taken place between Hong Kong and the Zhujiang delta. After China's entry to the WTO on 11 December, 2001, such economic integration will be further strengthened. A world-class city-region is being formed in the Hong Kong and Zhujiang Delta area.

Pressing issues and concerns of effective resource management, governance and sustainability are emerging due to accelerated industrialization, urbanization, globalization and regional integration. They will affect the further development and prosperity of the region.
